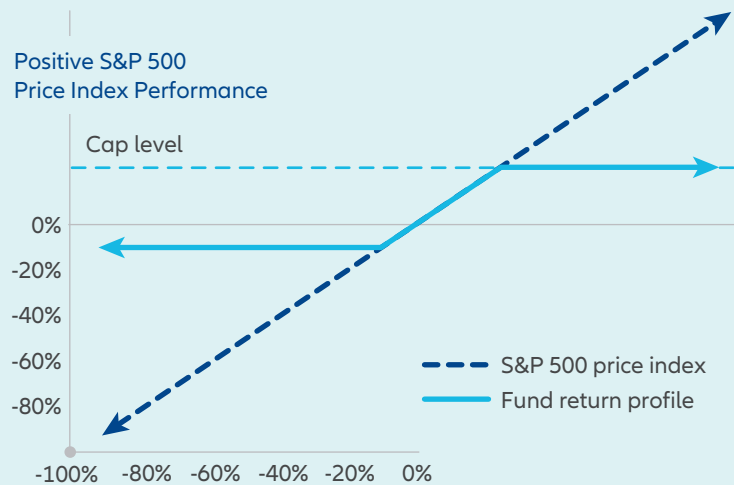

In the event that the S&P 500 Price Index, or SPDR S&P 500 ETF Trust, has gains in excess of the Cap for the Outcome Period, the Fund will not participate in those gains beyond the Cap. Despite the intended Floor, a shareholder could lose their entire investment. An investment in the Fund is only appropriate for shareholders willing to bear those losses. The Cap and Floor, and the Fund's position relative to each, should be considered before investing in the Fund.
